a) That the current Officers of Chair, Secretary, and Treasurer, be designated as the Management Committee for the purpose of supervising the winding up of the Local Party (on District Boundaries); the approval of its accounts for the year ended 31st December and the transfer of its assets to its successors.

b) That the activities of the Local Party (on District Boundaries) be suspended with effect from 31st December 2024, and that the Local Party then be dissolved, and its assets be transferred to its successors as directed by the Regional Party. c) That upon the accounts of the Local Party for the year ending 31st December 2024 being approved by the Management Committee and, if necessary, filed with the Electoral Commission, and upon all the assets of the Local Party being transferred to its successors, the Local Party (on District Boundaries) be dissolved.

An Inaugural General Meeting of the Cambridge Liberal Democrats (organised on constituency boundaries):

1) Election of a Chair for the meeting.

2) That the Cambridge Local Party, on Constituency Boundaries) be established as a Local Party of the Liberal Democrats in accordance with the Party Constitution and as the successor within its area to the Cambridge local party (on District Boundaries).

3) That the Draft Constitution (previously circulated) be adopted as the Constitution of the Local Party, subject to such amendments as may be agreed by the meeting and approved by the Regional Party.

4) Appointment of an independent person able and willing to report on the Accounts in accordance with Section 7.2c of the constitution.

5) Consideration of any Motions postponed to the meeting.

6) Declaration of those positions for which there is no need of an election and appointment of a Returning Officer to conduct any necessary elections.
